

# Master of Accounting (SUT) / Master of Science in Leadership(NU)

## Course Structure & Planner (Part time Students) Commencing Winter - 2009 (TP4)

The **MAcc(SUT)/MScLeadership(NU)**, program code **BMAC640U**, enables students to complete a two year program (or part-time equivalent) of study and gain two masters degrees on graduation. Students complete ten (10) units of study from the Swinburne Master of Accounting program and eight (8) units of study from the Northeastern Master of Science in Leadership via the Leadership Stream. Upon successful completion of all eighteen (18) of units of study (225 credit points), subject to pre-requisite requirements, students will be awarded: Master of Accounting (Leadership Stream) from Swinburne and Master of Science in Leadership from Northeastern.
