

POST GRADUATE PRACTISING ACCOUNTING PROGRAM 2010 Course Structure (Saturday part time block mode)

The Graduate Certificate of Professional Accounting (CMPA440), Graduate Diploma of Professional Accounting (CMPA540), ** Master Professional Accounting (CMPA640) and Master of Practising Accounting (CMPA740) form a nested program. A nested program is a sequence of study which is followed to obtain the highest available award and which has multiple entry and exit points. This structure allows students the flexibility to qualify for the ultimate award or exit at an earlier stage. Students may not receive multiple awards for continuous study in a nested program.
NOTE: **Students who are admitted into the Master of Practising Accounting(CMPA740) program but do not hold an undergraduate degree are not eligible to exit at the Master of Professional Accounting exit point. They must complete 16 units of study - The exit point below the 16 unit Master is the 8 unit Graduate Diploma of Professional Accounting (CMPA540).
