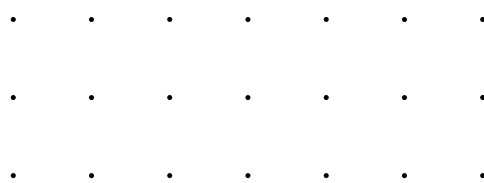

Manage WHS Procedures

Duration: 1 day

Location: Online, delivered live

BSBWHS514 Manage WHS compliance of contractors

BSBWHS520 Manage implementation of emergency procedures

Participants will learn the skills and knowledge required to lead and coordinate organisational arrangements for managing WHS compliance of contractors. It involves determining the WHS legislative and organisational requirements applicable to contractors, and managing compliance of contractors.

Participants will also learn the skills and knowledge required to contribute to the implementation of planning and response procedures for emergencies. The focus is on implementation of procedures already developed for short-term emergency responses. It assumes that expert advice will be available in identifying potential emergencies and in formulating response plans.

Learning objectives

Participants will be able to:

- establish and communicate WHS requirements in relation to contractors
- monitor contractor compliance with established WHS requirements
- review WHS requirements in relation to contractors
- Identify potential emergencies
- identify, plan implement, and review options for initial response
- manage post-emergency activities.

Lead in a WHS Environment

Duration: 2 days

BSBWHS515 Lead initial response to and investigate WHS incidents

BSBWHS519 Lead the development and use of WHS risk management tools

Participants will learn the performance outcomes, skills and knowledge required to plan, conduct, and report on investigations of WHS incidents that have resulted in, or have the potential to result in, injury or damage.

It covers conducting an initial assessment of the situation, establishing the scope and legal parameters of the investigation, conducting a systematic analysis to identify underlying causes and actions for prevention, and reporting on the outcomes of the investigation appropriate to the potential severity of the incident; which may include accessing specialist expertise.

The cluster also teaches the skills and knowledge required to lead the development and use of WHS risk management tools.

Learning objectives

Participants will be able to:

- lead the initial response to incident, develop and resource an incident investigation plan, and collect incident information and data
- lead an incident investigation that is not part of providing legal advice or preparing for legal proceedings and record and report WHS incident investigation
- select, develop, and lead the use of WHS risk management tools
- communicate outcomes of and review use of WHS risk management tools.

Participants will also learn to describes the skills and knowledge required to conduct WHS risk management processes. The cluster also describes the skills and knowledge required to contribute to managing work-related psychological health and safety.

Learning objectives

Participants will be able to:

- facilitate identification of WHS risk management requirements
- lead both risk assessment and risk control
- evaluate effectiveness of WHS risk management process
- access information and data on WHS hazards and risk management
- prepare to manage WHS risks
- develop and implement WHS risk-management processes
- establish requirements for managing work-related psychological health and safety and record and assess work-related psychosocial hazards in the workplace
- contribute to implementing risk controls for risks associated with identified work-related psychosocial hazards and review their effectiveness.

Participants will learn the skills and knowledge required to contribute to the development, implementation, and maintenance of elements of a work health and safety management system (WHSMS), which consist of a documented set of plans, actions, and procedures that target improvements.

They will also learn the skills and knowledge required to contribute to managing a work health and safety information system (WHSIS).

Finally, participants will learn the skills and knowledge required to manage the identification, review, development, implementation, and evaluation of consultation, and participation processes as an integral part of managing WHS.

Learning objectives

Participants will be able to:

- contribute to developing WHSMS and WHSMS implementation plan and support implementation of WHSMS
- contribute to measuring, evaluating, and reviewing WHSMS performance
- identify requirements for, review existing, and develop new WHS consultation and participation processes
- facilitate implementation of WHS consultation and participation arrangements
- monitor and evaluate WHS consultation and participation processes.
