# A. Applicants with recent secondary education (within past two years)

#### **ATAR**

This course uses the ATAR as part of its selection considerations.

Guaranteed ATAR: If you receive an ATAR of 65 or higher and meet all the essential requirements for this course, you will be guaranteed an offer.

#### **Educational history**

An applicant's entire academic history, including ATAR results, will be considered for entry into this course.

# Selection rank adjustments

Selection ranks for this course will be calculated based on your ATAR with adjustments to overall study scores based on subjects studied, location of your home address, SEAS application, and participation in Swinburne's Early Leaders program. For further details about selection rank adjustments, see <a href="Admissions">Admissions</a> at Swinburne.

# **Subject Adjustments**

A study score of 25 in any English, any LOTE, any Mathematics or any Science equals 2 aggregate points per study. Overall maximum of 10 points.

## Meeting course prerequisites

Units 3 and 4: a study score of at least 25 in English other than EAL or at least 30 in English (EAL).

# B. Applicants with higher education study

#### **Educational history**

An applicant's entire academic history, including results from previous higher education study will be considered for entry into this course. If previous higher education qualifications are incomplete, results must have been obtained in the last seven years.

Meeting course prerequisites

As for Year 12 or equivalent.

STAT/Bridging courses

Results from the <u>STAT Multiple Choice</u> will be considered for applicants without an ATAR and whose post-secondary studies do not meet the minimum requirements. STAT results are valid for two years.

# C. Applicants with vocational education and training

#### **Educational history**

An applicant's entire academic history from the past 7 years, including complete and/or incomplete post-secondary VET studies, will be considered for entry into this course. Only graded results will be considered.

Meeting course prerequisites

As for Year 12 or equivalent.

STAT/Bridging courses

Results from the <u>STAT Multiple Choice</u> will be considered for applicants without an ATAR and whose post-secondary studies do not meet the minimum requirements. STAT results are valid for two years.

## D. Applicants with work and life experience

#### Entire academic record

This course uses an applicant's entire academic record as part of its selection considerations, including an applicant's ATAR results from the last seven years can be considered for entry into this course.

Meeting course prerequisites

As for Year 12 or equivalent.

### **STAT/Bridging courses**

Results from the <u>STAT Multiple Choice</u> will be considered for applicants without an ATAR and whose post-secondary studies do not meet the minimum requirements. STAT results are valid for two years.
