Extra requirements for this course

Our Swinburne Law School courses provide practical opportunities for students in the classroom and through work experience, and we support our students to find placement opportunities within host organisations. Before graduation, all law students will be required to complete a total of 60 days of professional placements.

A. Applicants with recent secondary education (within past two years)

ATAR

This course uses the ATAR as part of its selection considerations.

Guaranteed ATAR: If you receive an ATAR of 85 or higher and meet all the essential requirements for this course, you will be guaranteed an offer.

Educational history

An applicant's entire academic history, including ATAR results, will be considered for entry into this course.

Selection rank adjustments

Selection ranks for this course will be calculated based on your ATAR with adjustments to overall study scores based on subjects studied, location of your home address, SEAS application, and participation in Swinburne's Early Leaders program. For further details about selection rank adjustments, see Admissions at Swinburne.

Subject Adjustments

A study score of 25 in any Business, any Humanities, any Information Technology, any LOTE, Maths: Specialist Mathematics or any Science equals 2 aggregate points per study. Overall maximum of 12 points.

Meeting course prerequisites

VCE Units 3 and 4: a minimum study score of 25 in any English (except EAL) or 30 in English as Alternate Language (EAL) or equivalent.

VCE Units 1 and 2: satisfactory completion in two units (any study combination) of any Mathematics or equivalent.

Bridging courses

Applicants who do not meet the mathematics prerequisites for this course will be required to successfully complete Swinburne's MathsLink Further bridging program.

Bridging courses

Applicants who do not meet the mathematics prerequisites for this course will be required to successfully complete Swinburne's <u>MathsLink Further bridging program</u>. Mathematics prerequisites older than ten years are not considered to have met course requirements.

C. Applicants with vocational education and training

Educational history

An applicant's entire academic history from the past seven years, including complete and/or incomplete post-secondary VET studies, will be considered for entry into this course. Only graded results will be considered.

Meeting course prerequisites

As for Year 12 or equivalent.

Bridging courses

Applicants who do not meet the mathematics prerequisites for this course will be required to successfully complete Swinburne's <u>MathsLink Further bridging program</u>. Mathematics prerequisites older than ten years are not considered to have met course requirements.

D. Applicants with work and life experience

Entire academic record

This course uses an applicant's entire academic record as part of its selection considerations, including an applicant's ATAR results from the last seven years can be considered for entry into this course.

Meeting course prerequisites

As for Year 12 or equivalent.

Bridging courses

Applicants who do not meet the mathematics prerequisites for this course will be required to successfully complete Swinburne's <u>MathsLink Further bridging program</u>. Mathematics prerequisites older than ten years are not considered to have met course requirements.
