National Student Safety Survey

The National Student Safety Survey (NSSS) ran across the Australian university sector in late 2021, with results released on Wednesday 23 March 2022. Like the foundational survey from 2016, the 2021 NSSS collected data on the prevalence and nature of university student experiences of sexual harassment and sexual assault.

Swinburne's findings

Of the 1,054 Swinburne students who responded to the survey, 12.9% had experienced sexual harassment since starting university, with 3.7% experiencing sexual assault in the past 12 months. 10.1% of the 'differently-described' gender students who responded to the survey have experienced sexual harassment, as had 4% and 2.5% of those who identified as women and men respectively.

We want our campuses to be a place that is welcoming and safe to all students, yet for some students they are not. 47.3% of the sexual harassment incidents were experienced in general campus areas, and 23.6% in lecture theatres and computer labs. 61.1% of students experiencing sexual harassment knew some or all of the perpetrators involved.

It was concerning that only 19.2% of students who were sexually harassed sought support or assistance, and more alarming that 52.3% and 54.5% of students who experienced sexual harassment and sexual assault respectively knew nothing or very little about how to make a complaint (54.4% in the circumstance of sexual assault). Similarly, 47.8% and 43.9% of student who experienced sexual harassment and sexual assault respectively knew nothing or very little about how to seek support or assistance. This was similar to the rest of the sector and clearly demonstrates that more needs to be done to ensure that all students know how to report, seek support and have an understanding of information and resources available to them.

Swinburne's response

The Respect. Now. Always. Taskforce will be reactivated to harness the university community to improve our performance. This RNA Action Plan, developed in consultation student leaders of the Student Representative Council and Swinburne Student Union, and the Safer Communities team, outlines the actions we will take across four key focus areas:

- 1. Improving awareness,
- 2. Improving education,
- 3. improving service provision, and
- 4. Gaining further insights.
