## Get admitted to practise law on the day you graduate

Did you know, before you become a practising lawyer, you need to complete Practical Legal Training, which can be taken as either a graduate diploma or a traineeship, on top of your bachelor's degree?

Swinburne law students are the only students in Victoria who are eligible to be admitted to legal practice on the day they graduate.

How? Well, to accelerate your learning, we've structured our law degree to give you the option of enrolling in a Graduate Diploma of Legal Practice through the Leo Cussen Centre for Law during the final year of your Bachelor of Laws.

With this dual award program, you'll get your legal practice credentials months ahead of the game.

### How the integration works

You'll have two options to fit the PLT into your degree:

**Option one:** If you want to do the PLT in your final year of study, you'll need to take on two (or more) additional units in the years preceding your final year. This frees up your time to tackle both the PLT and the last units of your degree in your final year.

**Option two:** If you'd rather fit the PLT into your final semester it's a similar process, you'll just need to plan your degree so you're only taking one unit of your degree in your final semester.

And, to help you balance study, work and life all year round, we offer law electives between semesters, in Summer and Winter terms.
