#### Participate in quality audits

*Duration:* 1 day *Delivery mode: Blended Location:* Live Online and Face-to-face (Hawthorn)

*Units:* BSBAUD411 Participate in quality audits

This workshop teaches participants how to prepare for, and participate in, a quality audit as a member of an audit team.

You'll learn the various audit processes including reviewing designated documentation; identifying and developing checklists and audit related documentation; preparing audit schedules; gathering, analysing, and evaluating information; and reporting findings to the lead auditor.

You'll gain an additional layer of knowledge that will allow you to analyse and evaluate information, assess findings, and participate in an exit meeting, ensuring the audit is closed out professionally.

- review audit documentation
- participate in the development of audit schedules
- gather, analyse, and evaluate data and information
- report findings
- · participate in exit meetings

#### Initiate quality audits

As a lead auditor, you need to know how to commence work on a quality audit project with an audit team.

This unit covers conducting entry and exit meetings; identifying and gathering relevant information; managing audit team resources; and providing feedback to audit team members on their performance.

The types of quality audit that will be covered by this unit includes either external or internal systems audits, process audits, or product/service audits.

#### Learning objectives

Participants will be able to:

- determine the scope and objectives of the quality audit with the auditee, client, and other stakeholders
- identify the relevant standards and compliance factors of the audit, as well as the identified risks
- communicate effectively with the auditee and other key stakeholders
- identify and brief the resources needed to conduct the quality audit, prepare the audit team, and review the auditee documentation
- prepare checklists, timelines, and documentation

#### Lead quality audits

Duration: 1 day Delivery mode: Blended Location: Live Online and Face-to-face (Hawthorn)

This is a key workshop in this program.

As participants lead their quality audits, they need to have a well-established theoretical knowledge base of quality auditing.

Participants also need to be proficient in using a wide range of specialised quality auditing and managerial techniques to carry out their own work and to supervise the quality of the audit team.

You will be able to set meetings and agendas, source data and information, monitor processes, manage resources and budgets, and mentor team members to perform at the top of their game.

#### Learning objectives

Participants will be able to:

- conduct a wide range of meetings, from entry and exit meetings to workin-progress meetings
- seek out and obtain data sets and information
- manage the resources of the audit team, including activities and personnel
- guide team members to continuously improve their performance
- communicate with key stakeholders and team members in an engaging and effective way

It's one thing to get an audit in the door. It's quite another to review the audit to ensure it contains the information you need, meets the criteria, and has clear recommendations.

Further, you need to be able to analyse the audit content, get it ready for internal stakeholder consumption, present and communicate the findings, and take the next corrective steps.

In this workshop, you will learn the key processes and frameworks that allow you to compile audit results, prepare reports, and handle all follow-ups.

#### Learning objectives

- compile the audit results against objectives and criteria and analyse the outcomes
- empower team members to grow, take responsibility for their own work, and support each other
- deliver evidence of any non-conformance within the report
- produce and present the final audit report to key stakeholders
- negotiate the follow-up process with the auditee, including corrective actions and potential improvements
- manage timelines, actions, and follow-up for any corrective actions
- evaluate the audit report against objectives and investigate potential improvements in audit methods, efficiency, and cost
